### **Nassau County Smart Sprinkler Reimbursement Program Application Terms and Instructions**

***Nassau County property owners or residents who installed a Smart Sprinkler controller in 2022, 2023 or 2024 may be eligible for reimbursement on the installation costs up to \$150.***

Nassau County homeowners can apply for a partial reimbursement (up to \$150 maximum) for the cost of installing a weather-based irrigation controller technology – also known as "Smart Sprinkler" controller systems. Smart Sprinkler is a weather-based irrigation product that uses real-time weather data to adjust an irrigation system's run times based on watering needs rather than on a preset, fixed schedule. Smart Sprinkler includes evapotranspiration based (ET) controllers.

The reimbursement program will not apply to residents who are already eligible through their water supplier for financial assistance in purchasing smart sprinkler technology, whether such assistance is in the form of discounted purchase price, discounted water charges, rebate, or other forms of assistance.

Qualifying property is residential property located in Nassau County.

#### **TERMS AND CONDITIONS**

Smart Sprinkler Controller must be installed by a Nassau County Licensed sprinkler system installer or Licensed Plumber in the town, city or village of the qualifying property. The Smart Sprinkler Controller was Installed after January 1, 2022 and prior to submitting your reimbursement application.

Limit 1 Smart Sprinkler Controller reimbursement per qualifying property.

Reimbursement does not apply to the replacement of an existing Smart Sprinkler Controller, or sales taxes.

Reimbursement cannot exceed the cost of installing the Smart Sprinkler Controller.

On-Site compliance verification may be required.

Funding for the reimbursement is limited and processed on a first come first serve basis.

Submission or possession of a reimbursement application does not guarantee receiving a reimbursement.

#### **PROGRAM ELIGIBILITY**

##### **Who is eligible to apply for the \$150 reimbursement?**

The eligible applicant is the owner or resident (tenant) who is the water utility account holder and pays the water bill on the qualifying Nassau County residential property. A tenant must attach a letter from the property owner which states the owner approves the tenant's request for reimbursement.

##### **What documentation is required to file an application for reimbursement?**

Each application must include –

\* The Installer's active Department of Consumer Affairs license number.

\* Invoice from service provider for installation of Smart Sprinkler including the name and model # of the Smart Sprinkler, date of installation, the charge for installation services separated from cost of Smart Sprinkler and any other product or service provided or rendered. *If Smart Sprinkler is purchased separate from installation, then provide date of purchase, name, and model #*

And

\* Proof of Payment for the installation invoice as described above, which notes the invoice # paid, amount paid, and date of payment including copy of cancelled check (front & back), or credit card receipt from service provider or a cash receipt.

And

\*Completed Form W-9 including name, mailing address, and Social Security number of the Applicant to receive reimbursement payment
